Application process



Stage 1: Submission

Submit your application. SEC will contact you to confirm licences and accreditations.



Stage 2: Assessment

SEC will interview shortlisted applicants and assess against endorsement criteria.



Stage 3: Onboarding

Successful applicants will sign a contract with the SEC and be onboarded.

- Be authorised under relevant rebate and incentive programs, such as Solar Victoria's Solar Homes program, and the Victorian Energy Upgrades scheme to be able to claim Victorian Energy Efficiency Certificates as well as Small Scale Technology Certificates on behalf of your customer.

SEC encourages regional and local businesses to apply, as well as those who service across the state.
